Course Title: Direct Support Internship III

Course Abbreviation and Number: COH 1020

Credit Hours: 1

Course Type: Internship

Course Description: Students will gain practical experience participating in a minimum of 45 hours of supervised work through an organization, agency, or hospital providing direct support services for clients. Students will apply the skills they have learned in service navigation and referral, networking, teamwork, ethics, and communication skills. Students will further learn how to advocate for individuals and families so that clients can live fulfilled lives integrated into the community. The student, faculty coordinator, and site supervisor will work together to create an appropriate learning experience for the student, which also includes a weekly seminar. Finally, the student will create a professional portfolio revolving around National Alliance of Direct Support Professionals standards (DSP-3) and earn the DSP-3 Certificate.
